C. SHARKEY ENTERPRISES, INC., will furnish **PREFERRED ANNUAL PREPAID SERVICE** to consist of 2 periodic inspections (including parts) beginning with "turn on" service in the Spring, and winterizing system in the fall, plus an additional call if necessary.

The purpose of this regular service is to maintain a consistently high quality of performance for your Lawn Sprinkler System through pre-scheduled service checks. In order to achieve more efficient service, C. SHARKEY ENTERPRISES, INC., reserves the right to schedule all service under the plan. Efficient maintenance will prolong the life of the equipment and make required adjustments to meet changing watering conditions in advance of damage to lawn or plants. Service alterations necessitated by possible change in water supply (city main water pressure) are, of course, beyond C. SHARKEY ENTERPRISES, INC., control and are specifically excluded from this contract.

The following work will be accomplished by C SHARKEY ENTERPRISES, INC., at its discretion on each periodic inspections:

- a. Raise spray heads to compensate for lawn growth.
- b. Trim grass around lawn sprinklers if required.
- c. Clean nozzles that have become clogged.
- d. Raise or lower risers in bed areas to compensate for shrub growth.
- e. Regulate nozzles for direction of throw and rate of discharge.
- f. Replace faulty nozzles or sprinkler heads.
- g. Renew operating valve parts if worn and leaking.
- h. Test control of timing and performance.
- i. Test system completely for adequate coverage.

PLEASE NOTE

This contract does not cover maintenance of pumps or pump controls nor replacement of time clocks.

All labor and parts for ordinary maintenance outlined shall be furnished by C. SHARKEY ENTERPRISES, INC., without additional charge. This contract does not cover labor, parts or materials required for repairs caused by fire, flood, accident or abuse. Repairs for any of these causes or alterations and extensions shall be subject to an extra charge agreed upon in advance between C. SHARKEY ENTERPRISES, INC., and the Customer.

ACCEPTANCE

Customer agrees to be bound by the terms and conditions herein. Further, the customer agrees that this document is the complete and exclusive statement of the understanding between the parties. Additional equipment may be added to this agreement, with a corresponding rate charge, at the request of the customer. **PLEASE NOTE: YOUR REMITTANCE FOR THE ABOVE AMOUNT MUST ACCOMPANY THE SIGNED UPPER PORTION OF THIS AGREEMENT TO ACTIVATE CONTRACT.**
